PROTOCOL

“Extraordinary claims require extraordinary proof.”

“Tests on burned cells in the laboratory are the simplest to set up. Give me cells burned by laser in the nucleus. We take half of those cells, and the ones I’m taking care of don’t die. The other half, the ones I’m not taking care of, of course, die.” (Dr. Philip Savage PhD)

METHODOLOGY

1. Conduct tests in dozens of laboratories around the world.
2. Lab scientists burn cells by laser in the nucleus.
3. Dr. Savage “processes” half the burned cells at a predetermined time.
4. Results are documented by laboratory scientists and media, including videos by TV reporters.
5. Continue testing in different labs around the world to compare results.
6. ALL tests to be conducted from a distance (non-locally).

DISCUSSION

Tests on Dr. Philip Savage’s ability to “process” and “save” burned cells were conducted in laboratories in Paris in 1987-1989 and Quebec in 1991. In all cases, Dr. Savage processed the cells in person and produced incontrovertible 100% positive results.

Dr. Savage explains the purpose and importance of these ground-breaking remote experiments:

*“By use of specific subliminal techniques which mentally channel bio-forces with unprecedented resultant potency, we want to establish the inherent consciousness of Life within the cellular domain. If, through Mind-Force only, we are able to affect significantly the functioning of individual or collective cells under the strictest scientific methodological supervision, **we will have proven that cells have a mind of their own and that such a mind can blend with another mind of a higher level with observable results.***

But I do not want to prove, only, that cells have a mind of their own and that such mind can be accessed, influenced and repaired. I want to demonstrate the oneness of the Mind per se, not only the organic unity of all cells' mind within one given physical body, but also the inter-connectiveness of all 'individual' minds within some higher unified field of consciousness, the Bio-Mind.

If I can achieve to alter the mind of preselected cells with clear observable clinical results by blending my own mind and the cells' mind into one single mental unity of higher rank, we would have blazed the trail toward providing the reality and potential connectivity of the Bio-Mind itself. That is why ONLY 'Mind Force' technologies must be employed if we want to have a chance to meet the epistemological criteria of such an experiment.”
